

# VOTE IN FAVOR OF THE FY 2008 LABOR, HEALTH AND HUMAN SERVICES AND EDUCATION APPROPRIATIONS BILL

July 10, 2007

Dear Representative:

The undersigned education, training, disability, public health, health and biomedical research, aging and child welfare organizations, elected officials, and labor unions representing the full range of stakeholders in the programs of the Departments of Education, Health and Human Services and Labor urge you to vote in favor of the FY 2008 Labor, Health and Human Services and Education Appropriations Bill when the bill is debated on the House floor. The bill, which received unanimous, bipartisan support by the Labor, Health and Human Services and Education Appropriations Subcommittee, provides a modest, 4.8 percent overall increase for programs in the bill, most of which have experienced significant cuts, lost purchasing power, or both over the past three years. This fiscally responsible effort to turn around the steady divestment in some of the most important domestic programs Congress funds deserves your strong support. America cannot sustain its global scientific and economic leadership, national security and citizens' health and well-being without increasing its investment in these critical program areas.
