Dear Jay and Luis,

I am incredibly excited to be a part of the phenomenal research and clinical team involved in this P01: Beyond ART: HIV-1 control mediated by Interferon-alpha Immunotherapy.

From the position of clinical recruitment for the proposed BEAT HIV study, as you know, I am the chief of infectious diseases at the Philadelphia VAMC where our clinic follows more than 500 HIV infected persons, approximately half of whom are HIV monoinfected. I am eager to identify and help lead the clinical Core effort with Dr. Kostman by recruit interested patients from our clinic to participate in the study as well as interface with referral clinics and stand as Deputy Clinical Core Leader for the Core/Study at times Dr. Kostman may be away (i.e., vacation, conference) and a need for expedited action is needed (eg., SAE reporting to FDA per BEAT HIV IND study).

As you know, I have a particular interest in the clinical management of Peg-IFN-a-based therapies as I focused in research and care of coinfecting subjects with HIV and hepatitis C. I am currently the national vice chair on ACTG5269 which is a study in coinfecting persons looking at the effect of nitazoxanide (NTZ) in addition to pegylated interferon and ribavirin on the treatment of hepatitis C in HIV/hepatitis C (genotype 1) coinfecting subjects that we will be presenting at the IAS conference in Rome later this month. I also can confirm that I will support sample usage from this study for Project 2 as already evidenced by a letter by the protocol chair to Dr. O'Doherty (PI, Project 2) -- as this study will provide a unique opportunity to address the question of what effects, if any, does long-term 48 week treatment with IFN+NTZ have on the HIV reservoir is staying on ART (as opposed to BEAT HIV design where ART is interrupted after 12 weeks of IFN+NTZ).

My participation in managing local patients taking IFN+NTZ in the ACTG5269 trial, in addressing clinical questions from sites across the US and Puerto Rico, and my frequent review of adverse events occurring among patients in this trial has enhanced my understanding of the appropriate clinical management of patients receiving interferon, as well as nitazoxanide. I am looking forward to bringing that experience and expertise to the BEAT HIV Study and P01 team in general.
