CASA Columbia received an unrestricted grant for its work on the diversion and abuse of controlled prescription drugs in the U.S., cited in this article, from Purdue Pharma LP. Because Purdue Pharma manufactures OxyContin - one of the drugs discussed in this report - CASA required and received written confirmation from the company that the grant could be used in any way CASA saw fit, and that Purdue Pharma would not be involved in the conduct or reporting of the research. For this report, CASA Columbia also received funding from WellPoint Health Networks Inc. to conduct the surveys of health practitioners about their practices, attitudes and perceptions related to prescription drug misuse. All CASA research is conducted independently and with the oversight of an independent advisory commission. To eliminate the possibility of real or perceived influence by the pharmaceutical industry, CASA restricted its Advisory Commission membership to leaders in the field with no financial ties to pharmaceutical manufacturers of controlled drugs that might in any way compromise their involvement.
