opportunity to focus attention at the ACP national level on a particular issue or topic that concerns them. Participating in the Board of Governors resolutions process provides the ACP grassroots member a voice and allows you to shape College policy that impacts the practice of internal medicine.

Not sure how to begin drafting a resolution? Researching the College's position on an issue can give you a start. The recently released *ACP Board of Governors Resolutions Guide for ACP Members* is now available to download and will help, too. *The Guide* was created to provide members a short overview of the resolutions process essentials and highlights critical ACP online resources you must use.

Once drafted, members must submit resolutions to their Governor and/or chapter council. Chapter council approval to move resolutions forward to ACP national is required. A resolution becomes a resolution of the chapter once the chapter council approves forwarding it to ACP national. If effecting change interests you, the deadline for submitting new resolutions to be heard at the Spring 2024 Board of Governors Meeting is **October 16, 2023**.

EDUCATIONAL AND OTHER ACP OPPORTUNITIES YOU DO NOT WANT TO MISS

1. SUBSTANCE USE DISORDER (SUD) EDUCATION: NEW DEA REQUIREMENT

Beginning on June 27, 2023, the DEA will require one-time attestation of training on management of substance use disorders (SUDs) prior to renewal of a DEA registration.

The DEA has released guidance on the new one-time requirement for completion of eight hours of training on the treatment and management of patients with opioid or other SUDs.

As an ACCME-accredited CME provider with Commendation, ACP offers a wide variety of recommended activities that count toward meeting the new DEA attestation requirement.

Leadership Day: Finding Your Voice as a Physician Advocate

Leadership Day is the annual advocacy event at Capitol Hill. American College of Physicians members across the country get together and discuss our issues with U.S. lawmakers. Every year the college prioritizes issues for internal medicine physicians and discusses them with U.S. lawmakers to influence policy making.

In my clinical practice, I realized the need to stand up for my patients. Advocacy starts in the examination room when I am advocating and fighting for my patients. I soon realized the "Power of One". I felt compelled to raise my voice and concerns for my patients. It starts with that one conversation with my patient or my colleague.

It really starts when we notice the need for a change. It could be unequal reimbursements, physician shortage, pre-authorization and many more. I realized something needed to change and I made sure my voice was heard.

The discussion felt very similar to having a sincere conversation with one of my patients. I made sure I was listening and finding ways so that they would trust me. Then making some space for conversations to start. Making small but steady progress. Finally taking small wins and working towards big ones. It then occurred to me that Advocacy is a long journey, and we will need directions and mentorship along the way.

This year we advocated for increasing residency spots and making some progress towards decreasing physician shortage. We also discussed the REDI Act (Resident Education Deferred Interest), which allows residents to defer their student loans during training. Prior authorization causes patient care delays and is also very time-consuming. We discussed exceptions to the Safe Step Act so we can focus our resources wisely. Some other issues were kids' access to primary care and strengthening Medicaid reimbursements. It was a great way to learn leadership skills and interact with physician leaders from across the country.
