Dear Speaker Johnson, Leader Thune, Leader Jeffries, and Leader Schumer,

On behalf of healthcare professionals and patients across the country, the undersigned organizations write to express our serious concerns about the harmful impact cuts to the Medicaid program could have on the nation's mothers and families. As you consider policy proposals, we urge you to reject those that weaken the program or create barriers to care for patients, particularly pregnant and postpartum women, children, and families.

Currently, Medicaid covers more than 40 percent of births nationally and more than 50 percent of births in at least four states.<sup>1</sup> Nineteen percent of adult women are enrolled in Medicaid.<sup>2</sup> Together with the Children's Health Insurance Program (CHIP), Medicaid provides more than 1.5 million low-income women access to the pre- and postnatal care that is essential to healthy pregnancies and healthy infants. Any disruptions in this care could have severe negative effects on the already unacceptable maternal and infant mortality rates in the United States.<sup>3</sup>

In 2021, Congress enacted critical legislation that for the first time created an option for states to extend Medicaid's postpartum coverage to 12 months. The Centers for Disease Control and Prevention (CDC) reports that 30 percent of maternal deaths occur between 43 and 365 days postpartum,<sup>4</sup> confirming that postpartum Medicaid extension can and does save lives. As of February 2025, 48 states and the District of Columbia have adopted this extension policy.

Proposed changes to Medicaid, including altering the federal-state cost sharing structure and adding barriers to coverage such as work requirements, will force states to make

decisions that could limit coverage for pregnant women, new mothers, and their newborns. For instance, to address budget shortfalls created by Medicaid reforms, states could choose to lower Medicaid and CHIP income eligibility limits for pregnant women or eliminate the life-saving postpartum extension. Further, reductions in federal support could force states to reduce Medicaid provider reimbursement rates, causing maternity care clinicians to leave the program or limit the number of Medicaid patients they care for.

Medicaid cuts that would reduce program eligibility or erect barriers to enrollment threaten to increase uncompensated care and attendant medical debt, which could accelerate closure of labor and delivery units in rural and underserved communities.<sup>5</sup> Additional closures would increase the number of maternity deserts, counties with limited or no access to maternity care, across the United States.<sup>6</sup>

We appreciate the opportunity to uplift the needs of pregnant and postpartum women and the importance of the Medicaid program to their health. We look forward to working with you to improve the Medicaid program so it continues to deliver on the promise of healthy mothers, infants, and families.
