Awards are given for the most outstanding abstracts in two categories: Clinical Vignettes and Research. Winners will be eligible for entrance into the national competition held at the national Internal Medicine Meeting in 2026.

Oral Presentations

Residents and students with posters in the QI/research category can now also opt to be considered to present their poster in a special oral presentation session.

Doctor's Dilemma

In this session, teams of residents from programs across the state compete against each other in a test of their medical knowledge in a Jeopardy-style competition.

Chapter Awards

9. Incorporate EBM principles into clinical reasoning
10. Review the AI models and platforms in healthcare, current and in pipeline: their challenges and advantages
11. Develop an understanding of the landscape of how and where patients usually interact with AI deliberately or inadvertently
12. Visualize the ethical risks and trustworthiness of AI in the digitalized healthcare models
13. Recognize common symptoms and clinical features of perimenopause
14. Apply evidence-based hormonal and nonhormonal treatment strategies for management of perimenopausal symptoms
15. Understand new data and recommendations of greatest importance to their outpatient general medicine practices
16. Reflect on cases of hypertensive emergency and assess whether treatment was warranted
17. Generate explanations for the use of transfusion thresholds and assess their validity
18. Commit to describing anti-platelet medications in some patients on anticoagulation for both coronary artery disease and atrial fibrillation
19. Apply recent evidence-based updates in hospital medicine to optimize diagnostic efficiency, risk stratification, and inpatient management decisions for common clinical conditions
