It might be helpful to many of you to better understand the administrative structure of the ACP. I must confess that I didn't fully understand it myself before election to Governorship. Each of the 85 chapters of the ACP has an elected Governor, except that in Florida, we are the world's largest chapter and get 2 governors. The Governors meet twice yearly to help guide the direction of the College and to make your voice heard by the College. The final decision-making body of the ACP is the Board of Regents who consist of officers and elected members. Dr. Jason Goldman, past Governor of Florida ACP is a member of the Board of Regents. The Board of Governors advise the Board of Regents.

The annual residency match is just around the corner and will likely be available by the time of this newsletter. We hope to see as many as possible of our state's more than 40 Internal Medicine residencies at our Chapter meeting on March 25. This meeting has grown exponentially as the expansion of undergraduate and graduate medical education has taken place in Florida over the last 15 years. The medical school population in Florida has also grown at a blistering pace.

Happy New Year, Internal Medicine Physicians!

While 20th century sci-fi themes about 2023 haven't exactly come true according to schedule, I couldn't imagine the growth of medicine and technology in 2023. Telemedicine. Remote patient monitoring. Personalized medicine. Directed therapies for cancer and autoimmune diseases. CAR-T-cell therapy. And now, nascent

artificial intelligence such as ChatGPT. This may indeed be the start of a Golden Age in Medicine. We are fortunate to have some of the most innovative and brightest researchers and physicians right here in Florida, many of them Internal Medicine physicians. While these advances have tremendous promise for patients and our ability to customize treatments for patients with better efficacy and reduced adverse events, they also place increased burden on us to learn about new therapies, manage more complex treatments, evaluate the utility and validity of tests and treatments, and educate our patients. Medical and "medically-adjacent" technology can also be a boon or burden. I was recently at the annual Consumer Electronics Show (CES) in Las Vegas. For the first time, there was a section on Health Technology. Tech companies are increasing their presence in the medical space – sleep trackers, urine testers, and strangely enough software using your computer's camera to determine your diabetic and cardiovascular risk. Many of these products will not pan out and get FDA approval. However, the difference now is that these companies are targeting patients directly instead of augmenting physicians' abilities to care for our patients. Whether or not you see this as a good thing, we as physicians will have to learn about these technologies, the questions our patients will ask (grumbling about Dr. Google may soon seem quaint), and other new treatments and approaches to preventing, maintaining, and treating disease and unhealthy habits. That is why I was proud to see over 200 attendees at our well-received and positively-rated Annual Scientific Meeting in October 2022 in Ft Lauderdale where we learned about new therapies, new ways of thinking about medical care, and controversial topics that are affecting our patients now. Gratitude to our many Florida and out-of-state internal medicine leaders and experts who spoke at the meeting. Special thanks to all those, particularly Dr. Claudio Tuda, who put together our inaugural POCUS workshop, a tremendous success.

One of my goals for my term as Governor is inclusion. I am happy to report that the Chapter has just created an International Medical Graduate (IMG) committee and a Women in Medicine (WIM) group. I am also passionate about wellness in

our profession. That is why I am excited about the work that our Wellness Committee has done over the last year and the activities planned for this year. Please reach out to us if you are interested in any of these groups.

The American College of Physicians has embarked on a re-branding of our specialty to improve the visibility and understanding of our important specialty to healthcare while combating confusion and misinterpretation. While "internist" is still a correct term, the public has been confused about what that means. Importantly, we are part of the backbone of the healthcare system, particularly primary care. We are not providers. We are not equivalent to nurse practitioners or other advanced practice providers. If the COVID-19 pandemic has not demonstrated the vital importance of primary care, including internal medicine, to healthcare in every community, then the last twelve months has shown what shortages in internal medicine physicians in many communities has done, including insufficient preventive care services and long wait times to see a primary care physician. Furthermore, there are predictions from industry analysts that primary care is declining, particularly among younger generations. We all know the importance of internal medicine for adolescents and adults, what lack of access and ongoing follow-up can lead to, the value we provide to the system in reducing hospitalizations, and the longitudinal relationships we provide our patients in their medical care. We are vital to the future of society. We are part of the solution to ensure primary care does not, in fact, decline.

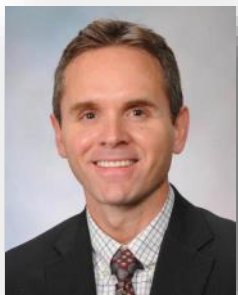

field. Look out for emails and zoom links. If you have a topic you are interested in hearing about or talking about, please reach out!

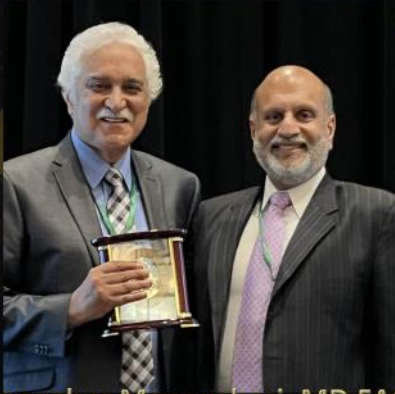

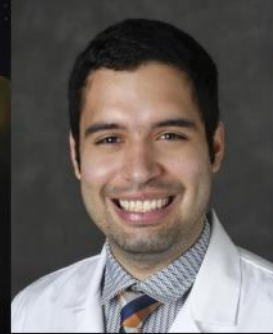

2023 CALL FOR AWARD NOMINATIONS

Florida Chapter American College of Physicians Outstanding Member Awards

Nominations for Awards due on or before August 1, 2023.

Nomination Requirements:

Nominees must be active members of the Florida Chapter, American College of Physicians. All submissions must include candidate's curriculum vitae, and a letter of nomination that includes a detailed statement of their activities for which he or she is being nominated, and any other pertinent information.

Florida Chapter will notify both the nominator and awardee following the Awards Committee meeting. This year's Awards Ceremony will be held live on October 28, 2023 at the Governor's Reception during the Chapter's Annual Scientific Meeting the weekend of October 27-29 at the Grand Hyatt, Tampa Bay. One of the goals of the Florida Chapter American College of Physicians is to "recognize excellence and distinguished contributions to internal medicine." As a way of achieving this goal, the Chapter offers the following awards. If you know a Florida ACP member deserving of recognition, please consider submitting a nomination for one of the Chapter Awards.



★ **Florida Chapter Laureate Award:**

Laureate Award is the most prestigious award given by the Chapter. It honors Fellows or Masters of ACP who have demonstrated by their example and conduct an abiding commitment to excellence in medical care, education, or research, and in service to their community, and their chapter of the American College of Physicians. A candidate must be long-standing and loyal supporter of the College who have rendered distinguished service to the Florida Chapter and have upheld the high ideals and professional standards for which the College is known. A candidate must be a Fellow or Master of the College for at least ten to fifteen years. The Laureate winner will be announced during the Florida Chapter Annual Award Reception.

★ **Florida Chapter Internist of the Year**

Award:

A physician who has demonstrated outstanding leadership and dedication to the clinical practice of internal medicine. Consideration should be given to the totality on an individual's career. Typically, awardees will have spent at least a decade of service to their profession and to the American College of Physician, though this is not a prerequisite.

★ **Florida Chapter Early Career Physician**

Award:

A physician who is in practice for 16 years or less from medical school graduation, highly respected by his/her colleagues for outstanding clinical and leadership skills, and who has been a role model in the community. This individual should have distinguished themselves in service to patients, the physician community, and the community at large. The awardee should be an educator to patients and the overall medical community as well as an active member of ACP who has contributed meaningfully to the efforts of the chapter.

★ **Florida Chapter Community-Based**

Teacher Award:

A physician who has demonstrated outstanding leadership and who has contributed to the education of medical students, residents, and fellows as an office-based internist.

★ **Florida Chapter Outstanding**

Teacher of the Year Award:

A physician who has demonstrated outstanding leadership and dedication to medical education.

★ **Florida Chapter Outstanding Contributions to Advancing the**

Careers of Women in Medicine Award:

The Florida Chapter American College of Physicians recognizes the accomplishments of an ACP Florida woman member for distinguished contributions to advancing the careers of women in medicine. This award recognizes an individual who has furthered the careers of women medical students, residents, and/or physicians through mentoring and leadership development for the career advancement of women.

★ **Florida Chapter Key Contact Award:**

A physician who has made exceptional efforts in support of the Chapter's state and federal advocacy programs throughout the past year.

★ **The Tulisa LaRocca, MD**

Wellness Champion Award:

The *Tulisa LaRocca, MD Wellness Champion Award* recognizes an individual or a program whose focus on wellbeing and/or wellness efforts is innovative and extraordinary. Individuals may be recognized for his/her own training, achievements and dissemination of wellness concepts. These activities may be at a local, regional or other level. Individuals who participate in Chapter initiatives will be given special consideration, but those who have participated in national efforts are eligible and encouraged to share activities locally. Institutions may be recognized for their efforts towards developing programs that enrich the personal and professional lives of physicians and trainees. Institutions may also be recognized by submitting their blueprints for wellness programs and agree that dissemination of such programs is permitted and will serve our professional community while acknowledging the institution's pioneering efforts. The *2020 Inaugural award honored Dr. LaRocca life and was presented to her family.*

★ **Florida Chapter Service Award:**

In Recognition of Meritorious Service to our State & the Medical Profession.

★ **Charles K. Donegan Memorial Award:**

In Recognition for Distinguished Community Service.

★ **Florida Chapter John G. Langdon Volunteerism in Medicine Award:**

A physician, who has distinguished themselves in voluntary service in the area of medicine like a commitment to continuing education, which is an established tradition for internists and the College. The College considers volunteerism so important that it is a major criterion for advancing to Fellowship. Recognize a colleague who actively participates in community service and volunteerism.

★ **Florida Chapter Gary F. Izzo Memorial Resident Scholarship Award:**

Established by the Florida Chapter ACP in memory of Gary F. Izzo; FPIC Vice President of Marketing and a personal friend to many Florida Chapter members; who devoted his life to improving the medical profession. The award is presented to a resident who, despite all the other pressures of being a resident, advocates to improve the practice of internal medicine.
