#### **President's Message**

One of the most important things we can do for advocacy is to participate in the process, which includes meeting with our elected officials and making them aware of how their actions can affect our profession and our patients. I had the privilege, once again, of taking residents with me to Tallahassee to meet with our state legislature. This past week was quite busy as we saw over fifteen members of the House and Senate. The key to advocacy is understanding who you are talking to and what the political motivations are. Regardless of party, we can always find common ground to start from.

There are several issues ahead for the 2020 session that we will be following and advocating for on your behalf. Next week, the House Health Quality Committee will debate HB 389, which would allow pharmacists to diagnose and treat influenza and strep. It is obvious to physicians that pharmacists are not trained in how to fully evaluate a patient, determine a differential diagnosis, or understand the potential outcomes of wrong treatment or misdiagnosis. We will be opposing this expansion of scope of practice proposal to ensure the safety of our patients. We know that the practice of medicine is more than running a test and giving a pill. At the same committee, however, we will be supporting HB 309, which reserves titles, such

as "cardiologist" and "anesthesiologist", historically used by physicians, to allopathic and osteopathic physicians only. If passed, this will prevent non physicians from referring to themselves as ologists.

In addition to the above issues, we have actively been opposing expected Scope of Practice expansions by nurse practitioners, physician assistants, and pharmacists, as well as promoting bills that will require PBM transparency and further restrictions on Step Therapy (HB 561 and SB 820 were the bills filed this week on these subjects).

It is critical that everyone gets involved as we will most assuredly be facing scope of practice expansion again this session and this can prove quite harmful to the practice of medicine and the patients. From in person visits to phone calls to helping with campaigns; there are plenty of opportunities for grassroots advocacy. I was exceptionally pleased with the reception we received from the majority of the elected officials and it is good to know that we have many supporters and friends in state government who continue to respect and value their physicians. I am proud of our residents who did an exceptional job presenting the issues in Tallahassee. While we may not always succeed on every issue before us, we will continue to advocate and be part of the process. Please become involved and continue to work for our profession.


