Illinois Downstate 2019 Governor Election

In 2019, your ACP chapter will elect a new governor to serve from May 2021 through April 2025.

A nominating committee will receive and review nominations and then prepare a ballot for the election. The Chair of the Nomination Committee is Janet A. Jokela, MD, MPH, FACP, FIDSA. Please look for more information on nomination soon.

The major duty of the Governor is to represent the members of her/his ACP Chapter. The Governor communicates with members and solicits the opinions of members. Then the Governor conveys the will of the ACP members to the Board of Governors and Board of Regents.

The Governor is responsible for the administrative functions and finances of the ACP Chapter. The Governor performs her/his duties with the advice of the Governor's Advisory Council.

The person who wins the election in 2019 will be called the Governor-elect designee from the date of election until 24 April 2020. Then, the winner of the election becomes the Governor-elect from 25 April 2020 until 30 April 2021. The Governor-elect will become the Governor from 1 May 2021 through April 2025.

ACP Encourages Members to Comment on Draft Recommendations about the Future of MOC

The Continuing Board Certification: Vision for the Future Commission, established by the American Board of Medical Specialties (ABMS), has <u>released its draft report</u> for <u>public comment</u>. The report includes the Commission's key findings and recommendations, and will be open for public comment until Tuesday, January 15, 2019 at 11:00 p.m. CST.

Feedback collected during the public comment period will help shape the Commission's final report and recommendations on future continuing certification (maintenance of certification) programs. The final report will be submitted to the ABMS Board of Directors in February 2019.

The ACP encourages you to review the draft report, submit comments and share this information with colleagues.

Call for Fall 2019 Board of Governors Resolutions

Are you concerned about a practice or clinical issue or have an idea you'd like to suggest? If so, you might consider submitting a resolution to your Governor or chapter council.

Initiating a resolution provides ACP members an opportunity to focus attention at the ACP national level on a particular issue or topic that concerns them. Participating in the Board of Governors resolutions process provides the ACP grassroots member a voice and allows you to shape College policy that impacts the practice of internal medicine. When drafting a resolution, don't forget to consider how well it fits within <u>ACP's Mission and Goals</u>. In addition, be sure to use the College's 2018-2020 Priority Themes to guide you when proposing a resolution topic.

Not sure how to begin drafting a resolution? Researching the College's position on an issue can give you a start. Visit the ACP Online homepage and click the "Advocacy" link in the right-hand, top margin to access ACP policy positions, read about recent ACP advocacy activities, or search ACP's library of policies and recommendations. Visit your chapter website, too, and click the link under "Advocacy" to access Electronic Resolutions System (ERS) where you can search past or proposed resolutions. A copy of the resolutions process is available on the ERS which furnishes more details on formatting resolutions, as well the process for submission, review, and approval.

Members must submit resolutions to their Governor and/or chapter council. A resolution becomes a resolution of the chapter once the chapter council approves it. If effecting change interests you, the deadline for submitting new resolutions to be heard at the Fall 2019 Board of Governors Meeting is **March 25, 2019**.

Make Your Voice Heard: Join ACP and the Physician Movement #ThisIsOurLane Responding to National Rifle Association over Policies

ACP's <u>updated position paper</u> on reducing firearm-related injury and deaths in the U.S. recently published in *Annals of Internal Medicine* has received major national attention and sparked the physician movement #ThisIsOurLane on social media.

On Nov. 7, the National Rifle Association (NRA) tweeted a link to an article on their website opposing ACP's recently updated policy on firearms safety, telling physicians, "Someone should tell self-important anti-gun doctors to stay in their lane." ACP and *Annals* immediately responded directly to the NRA's tweet, asserting that physicians engaging in advocacy to reduce injuries and deaths from firearms, like any other public health risk, is precisely in their lane. The College followed up with a comprehensive social and earned media effort to get the message out widely to the public and the profession.

Reaction on Twitter was swift and overwhelmingly in support of ACP's policy, with ACP members and other physicians and healthcare professionals declaring, "This IS my lane." The hashtag #ThisIsOurLane is being used to tag tweets where physicians call attention to the impact of firearms violence on their patients. The ensuing viral 'twitterstorm' has resulted in nearly 1,000 additional physicians signing a pledge on the Annals of Internal Medicine website, formally committing to talking to their patients about guns whenever risk factors are present.

Make your voice heard, and help us continue to raise visibility around this issue. Encourage other ACP members and physician colleagues to join the conversation on social media using #ThisIsOurLane, and tag @ACPinternists and @AnnalsofIM, and sign the <u>pledge</u> on the *Annals of Internal Medicine* website, formally committing to talking to their patients about guns whenever risk factors are present.
