POSTER COMPETITION

- 1. Abstracts are due on **August 30, 2020. NO LATE ENTRIES**. Abstracts must be prepared as directed and submitted using the online submission link. Abstracts may not be longer than 450 words (not including title or authors). References are included in the 450 word limit.
- 2. Each person may submit no more than one abstract to each category, with a maximum of two total submissions (e.g., may submit one to Clinical Vignette and one to Patient Safety/QI category, or any other combination of two categories).
- 3. <u>Posters must be on display at the hotel on Thursday, October 29, 2020</u>. Poster judging will take place on October, 29, 2020.
- 4. Posters may be 4' wide x 3' tall <u>maximum</u>. Posters larger than 4' x 3' will not be accepted. Materials to hang posters will be available at the display area.
- 5. A single, lightweight poster is recommended for ease in displaying, however, the format is up to the presenter. The print on the posters should be large enough to be readable from three feet.
- 6. Posters will be numbered and displayed in a designated area. Please hang your poster only in the area designated for your work.

- 8. You must be at your poster during the *Formal Poster Judging* on October 30, 2020. If you are not present at your poster to interact with the judges, you will not be eligible for a significant number of points.
- 9. ACP Indiana will accept 20-26 posters. Abstracts falling into a lower acceptance pool will be accepted as an abstract or e-poster to be displayed on ACP Indiana Website.
- 10. Award presentations will be **October 29, 2020**. All presenters are expected to be present for the awards portion of the meeting.
- 11. The first author of the abstract must be an ACP member, and a medical student or RFM at an Indiana medical school or internal medicine residency currently enrolled in a program. Faculty cannot serve as first authors as the primary purpose of this activity is to showcase resident/student scholarly activity.
- 12. Original abstracts that either have or have not been presented at other meetings (including ACP chapters/Regions) will be considered. Abstracts previously submitted to the National Meeting are not eligible and are subject to disqualification.
- 13. Presentation of original work at the ACP meeting may, however, jeopardize presentation before another society. Abstracts are eligible if they have been published; however, the resident should notify the journal that the material is being presented at the ACP Chapter meeting.

ORAL CLINICAL VIGNETTE COMPETITION

- 1. Participants must be ACP Indiana members in good standing.
- 2. Oral Clinical Vignette Abstract may NOT be used for the Poster Presentation Abstract.
- 3. <u>Two</u> residents from each of the Indiana Internal Medicine residency programs will be selected by their program to present an **oral clinical vignette**. Presenters must be PGY-2 or PGY-3.
- 4. **ACP Definition:** A clinical vignette is a report of one or more cases that illustrates a new disease entity, or a prominent or unusual clinical feature of an established disease. It may include a summary of pertinent patient history, physical findings, laboratory data, or management description.
- 5. Oral Vignette abstract submissions are due on <u>September 11, 2020.</u> NO LATE ENTRIES. Abstracts must be prepared as directed and submitted to <u>colleenkeekuacp@gmail.com</u> in a Word Document. Abstracts may not exceed 450 words.
- 6. Oral Vignette cases may NOT be presented as posters at the same meeting.
- 7. Vignettes may be <u>up to five minutes</u> in length, and may be followed by up to an additional three minutes for audience questions (total presentation and discussion= 8 minutes). <u>Oral vignettes will be presented Thursday</u>, October 29, 2020.
- 8. DOCTOR'S DILEMMA COMPETITION

- 1. Team members must be ACP Indiana members in good standing.
- 2. Teams must be comprised of 3 team members in any combination of PGY-1, -2, and -3. Program may select any combination for competition.
- 3. Team member names should be submitted to <u>colleenkeekuacp@gmail.com</u>. no later than September 11, 2020.

Doctor's Dilemma rules:

- 1. The tournament will consist of three rounds. Round 1 questions range from 100-500 points, Round 2 questions range from 200 1,000 points. Final Jeopardy consists of a points wager based on the number of cumulative points earned during rounds 1 & 2. Teams must have a positive point total at the end of Round 2 to participate in Final Jeopardy
- 2. Incorrect answers will result in negative points.
- 3. The team that selects the first question will be decided on the basis of a blind draw. Subsequently, the team to answer the last question correctly will get to pick the next category and question.
- 4. The moderator will read the question aloud. Moderator will stop reading and will not display the question on the screen if a team buzzes before the moderator completes reading the question.
- 5. If the team answers incorrectly, the moderator will begin to read the question again from the beginning.
- 6. After buzzing in, the team should wait to be acknowledged by the moderator before answering the question. After being acknowledged, the team must begin an answer within 10 seconds. The team members are allowed to discuss amongst themselves before answering. Answers should be in the form of a question.
- 7. If the answer is incomplete or partially correct, the judge may ask the contestant to clarify his or her answer. There will be no challenges to the answers at the time of the contest. The judge's decision is *final*.
- 8. Rankings will be based on scores. In case of a tie, sudden death question(s) will be asked with the first correct respondent deemed the winner of the round.
- 9. Each contestant is requested to maintain a respectable demeanor throughout the contest. Any disruptions in the contest room will result in the immediate elimination of the individual in question from the contest. The audience is asked to maintain silence and not shout answers.
