2021 Annual Scientific Meeting

As most of you know, the first completely virtual Annual Scientific Chapter Meeting was held in March 11-13. Though we all would have enjoyed an in-person experience, we were able to successfully offer a robust educational meeting. The weekend kicked off with two MOC sessions covering the latest updates in General Medicine and Hospital Medicine. The sessions were led by Chapter members Shahzeem Bhayani, Brian Cruz, Irene Grundy and Marlon Joseph.

The CME program on Friday featured numerous dynamic speakers and included disease updates on infectious diseases, hepatitis C and diabetes, and sessions on the hot topics of palliative care, value-based care and wellness. The day wrapped up with an ACP Vision for Medicine update from BOG elect Ryan Mire. The Resident and Student Meeting was held on Saturday and was a great success. The Call for Abstracts received over 120 submissions for poster presentations. During three-hour long sessions, 12 students and 22 residents participated in live poster competitions. There were two submissions chosen to be presented as mystery cases, which were interactive sessions between the presenters and the panel of judges. A highlight of the day, and the entire meeting, was the keynote speaker, Dr. Jay Marion. Dr. Marion joined the meeting to share his talk, "Navigating Turbulence During Difficult Patient and Colleague Encounters: Recognizing and Responding to Conflict", which was an hour that everyone, physician or not, was able to learn and glean useful tools for use in conflict resolution in life and the workplace. Chapter Bylaws

As discussed in the Chapter Business Meeting, held during the March Annual Scientific Meeting, the Chapter Bylaws are undergoing a revision. The purpose of the revision is to update the language to reflect the current workings of the Chapter, including options for holding meetings and votes on a virtual platform, defining an additional seat on the Council for a Northshore representative, and adding a Diversity, Equity and Inclusion statement. A Bylaws Committee was formed just after the March meeting, and they have worked diligently to revise the current document. The Bylaws have undergone a legal review, as required by ACP, to ensure that the statements made within the document are compliant with Louisiana state laws. The Bylaw revisions are being reviewed by ACP staff, then will be sent onto the Board of Regents for final approval.

Excellence in Internal Medicine Awards

Each year the Louisiana Chapter recognizes an outstanding student at each medical school that chooses to participate. This year the ACP Excellence in Internal Medicine Awards were given to: Michael Millet – LSU Shreveport, Bradley Powers – LSU New Orleans, Ashley Vellucci – Tulane.

Michael has started his Internal Medicine Residency at LSU. Brad has moved to Washington, DC to join the Internal Medicine Residency program at Georgetown with plans to go into General Internal Medicine or Cardiology. Ashley has joined the Vanderbilt Internal Medicine Residency program with plans to pursue a fellowship in Infectious Disease. Advocacy Highlights



The last few months were very busy for the Louisiana legislature and thus for our Chapter representatives, Celeste Newby and Ashley Ingolia. Dr. Newby and Dr. Ingolia represented the Chapter at White Coat Wednesday on April 21st. The annual event is an opportunity to meet with local legislators. This year the discussions continued to focus on the importance of keeping physicians as medical team leaders in making decisions about the healthcare of Louisiana citizens.



Louisiana Scope of Practice Bills

HB 442 (Physician Assistant) did pass through the House Health and Welfare Committee but failed to pass through the House (39:39) on May 11th.

HB 495 (Advanced Practice for Registered Nurses) passed through the House with a vote of 61:41 on May 5th and went onto the Senate. The bill made it out of the Senate committee and was placed on the calendar. However, a final vote was not taken before the summer recess began, therefore, HB 495 did not pass.



Drs. Angie Johnson, Celeste Newby, Ashly Ingolia, and residents Taylor Cravanas, Tonia Gooden and Axel Rodrigues Rosa participated in ACP Leadership Day on May 26th. Though virtual this year, this is an opportunity for Chapter members to meet with legislators on Capitol Hill in Washington, DC. Discussions with the legislative delegation focused on negotiating fair prescription drug prices, step therapy barriers to prescribing, increasing access to Telemedicine, supporting frontline physician workforce and increasing primary care training slots, improving access to behavioral health, and suicide prevention resources for physicians and other healthcare personnel.

LA ACP Resident Council

The Chapter Resident Council (RC) is charged with assisting the Governor and the Faculty Advisors in coordinating Resident/Fellow Member activities such as the regional research competitions, Resident/Fellow newsletters, and specific programs for trainees. The RC may also provide a forum whereby the needs and concerns of trainees in the Chapter are brought forward to the Governor and Governor's Council. The RC functions as an advisory group and may perform specific tasks in conjunction with the Governor and other appropriate organizations of the College at the local and national levels.
