MI-ACP and SHM-MI 2026 Resident and Medical Student Day - Call for Abstracts

Abstract submission is now open for both Residents and Medical Students for the MI-ACP and MI-SHM 2026 Resident and Medical Student Meeting, which will be held, Friday, May 1, at the Detroit Marriott Troy in Troy, Michigan.

Abstract submission will close on January 29, 2026 at 5:00PM.

Medical Students: You must be an ACP Medical Student Member and submitting work either done at a Michigan clinical site, or with primary mentorship from faculty within Michigan. There is no category available for individuals who have graduated from medical school but have not yet been accepted to a residency program.

You must be an ACP member to submit an abstract. Medical students must be a current member to access the Abstract Submission Page. Medical student membership is FREE. Please visit this [link](#) to join. If you need to join ACP, make sure to do so a few days before you try to access the Abstract Submission Links. It will take a few days for ACP to include you in the membership database. We are not able to extend the deadline for those who are not up to date in the membership database by the submission deadline.

Residents: You must be an ACP Resident/Fellow Member in an approved IM or Med/Peds Residency Program to submit and the work that is submitted must have been completed during residency. There is no category available for individuals who have graduated from medical school but have not yet been accepted to a residency program.

You must be an ACP member to submit an abstract. Residents must be a member and DUES must be current to access the Abstract

Submission Page. If you need to join ACP, make sure to do so a few days before you try to access the Abstract Submission Links. It will take a few days for ACP to include you in the membership database. MDHHS Statement Following Changes to Hepatitis B Vaccination Schedule by ACIP

In response to the recent ACIP vote to delay the birth dose of hepatitis B, the Michigan Department of Health and Human Services issued a [statement](#) urging families and providers to follow the immunization schedules from the American Academy of Pediatrics and the American Academy of Family Physicians.

Coaching for Impact: Empowering Early Career IMGs Practicing in Under- Resourced Communities

ACP has received funding from the ABIM (American Board of Internal Medicine) Foundation to support a new member-exclusive program: Coaching for Impact: Empowering Early Career IMGs Practicing in Under-Resourced Communities. This opportunity is part of a research study being conducted by ACP to assess the impact of coaching on physicians' professional development and fulfillment, physician retention in underserved communities, and physicians' ability to address challenges related to health equity.*

To be eligible for this cohort of the program, applicants must:

- Be an ACP member in good standing at the time of application through the end of the program (June 2026)
- Be an early career physician (within 16 years of medical school graduation) who attended and graduated from medical school outside of the United States
- Be practicing in an under-resourced, rural, or underserved community

Selected participants will be expected to:

- Attend four one-on-one live coaching sessions with their assigned coach during the duration of the coaching program (January-June 2026).
- Attend up to 3 group sessions during the duration of the coaching program (January-June 2026).
- Complete a pre-assessment prior to the start of the program (January 2026)
- Complete a post-assessment upon completion of the program (June 2026)
- Complete a final assessment six months after completion of the program (December 2026)

This program is at no charge and space is limited. Application does not guarantee a place in the program. Applications must be received by December 19, 2025. Physicians who are accepted into the program will be notified shortly after the deadline.


