Governor's Newsletter October 2019

Hello from your new Governor! I am excited to have the opportunity to represent North Carolina, and am happy to report that the American College of Physicians is working for you and with you.

At the national level, the Washington office is developing a New Vision for American Health Care, and is advocating on your behalf to policymakers in Congress and at CMS. One direct result is that in 2021, you will be able to justify billing Medicare based on just medical decision making or time, and not have to back-fill your notes with "bullet points" in the review of systems and physical exam to justify the level of service.

For more information, read the ACP statement, "<u>Internists Commend CMS for Bolstering Primary Care</u> and Supporting Patients in Proposed Physician Fee Schedule."

At the same time, CMS has also agreed to not "merge" the 99213 and 99214 billing codes. As a General Internist, this advocacy effort directly applies to my daily practice of medicine, and I think it will also be of great benefit to all of you.
