Internal Medicine White Coat Day at the Legislature, June 19

Joining the choir of ACP members in advocating for patient care is an exciting and rewarding experience. That's why I will again participate this year in the upcoming Internal Medicine White Coat Day at the Legislature, jointly presented by our NC-ACP and the NC Medical Society. On the morning of Tuesday, June 19, North Carolina internists will meet in Raleigh to learn about the health policy discussions taking place at the state level, and to meet with state legislators. Key topics this year will include health insurance access, Medicaid transformation, behavioral health integration, Controlled Substances Reporting System and opioids, and potentially others. The day kicks off at 7:30 am with a legislative briefing followed by scheduled meetings with legislators, and concludes with a debriefing lunch. This is a free event. you! Fifteen (15) BOG Resolutions advanced to the April 2018 meeting of the ACP Board of Regents (BOR), the policymaking body of the College, where they were discussed and voted on. A summary of the BOR's actions and final resolved clauses is attached for your review. BOG Resolutions to be considered at the Fall 2018 BOG meeting will be announced soon. Again, thank you for your participation and support in this process.

ACP Leadership Day Wrap Up

I have just returned from another empowering and impactful ACP Leadership Day in Washington, DC, where I was joined by our Chapter Governor-Elect Dr. Richard Wardrop, eight (8) of our NC-ACP colleagues and more than 350 ACP members from 48 states, DC and Canada. We were delighted to have a strong delegation of practicing physicians as well as residents and medical students participating in the annual advocacy event. We learned about the latest issues and legislation being considered by the U.S. Congress, and met with our U.S. Representatives and Senators to voice the concerns of internal medicine physicians and to promote policies that will improve the health of our patients. The key issues addressed at this year's event included:

- expanding coverage and stabilizing the insurance market.
- reducing unnecessary administrative tasks on physicians and patients,
- reducing prescription drug costs,
- funding for workforce, medical and health services research, and public health initiatives,
- promoting continued action to address the opioid epidemic,
- reducing firearms-related injury and death, and
- making Graduate Medical Education (GME) funding more effective.

I encourage every member of the ACP to review the Issue Briefs and other resources on the ACP Services website and to reach out to your representatives in Congress to convey your thoughts on these important issues.

Helping Patients with Weight Loss

Researchers with Duke University, the University of Colorado and Michigan State University are seeking to document what primary care practices are doing to help patients with weight loss so that policy changes can be developed to support primary care in this area.
