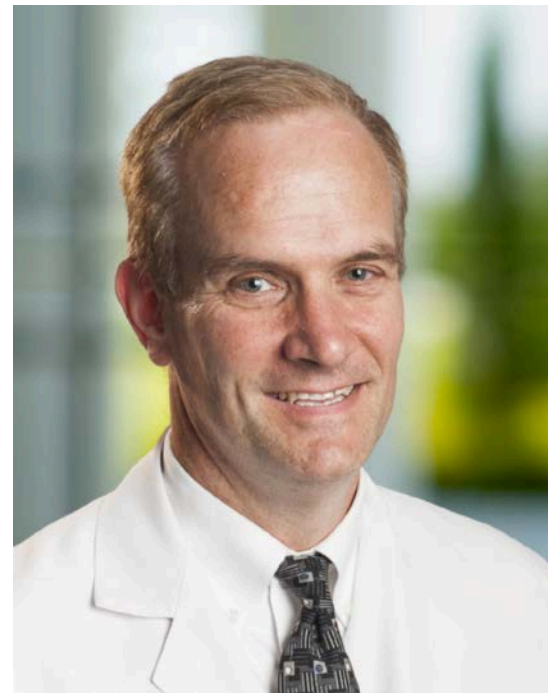

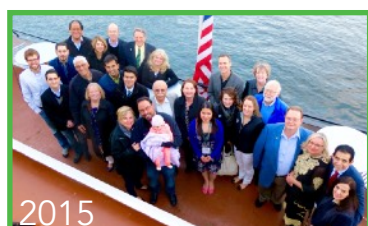


Oklahoma Chapter Reception Cruises the Delaware River

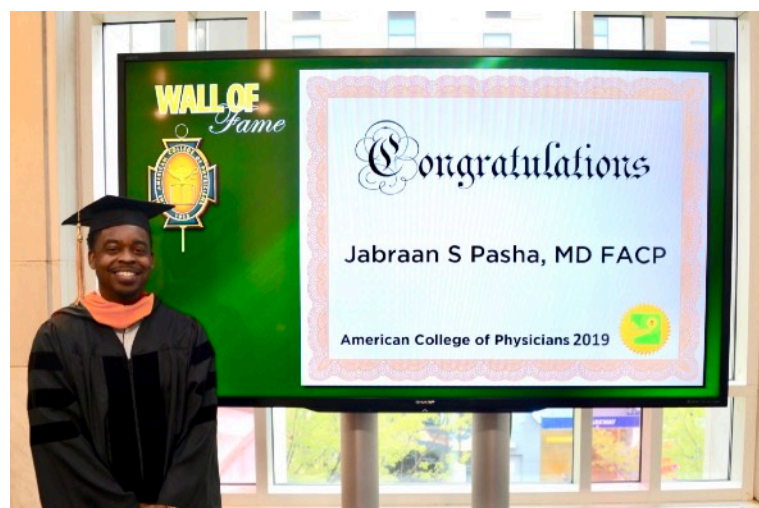

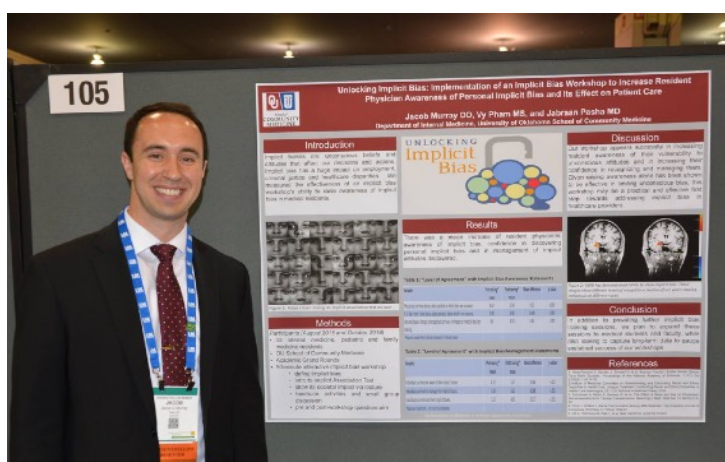

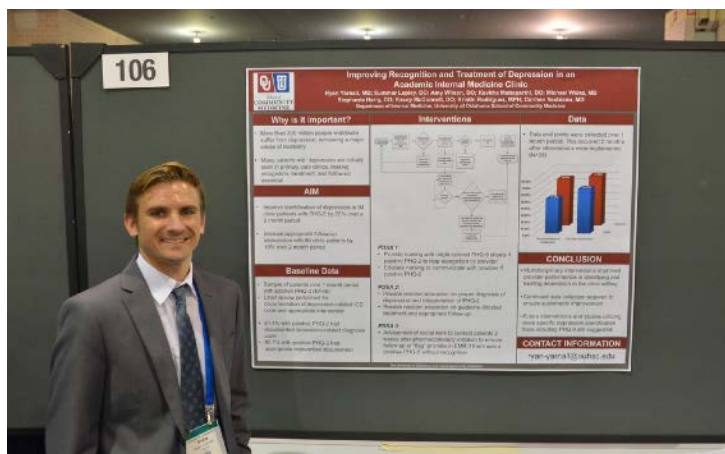
International Resident Poster Presentations

Leadership Day in Washington D.C.

In May 2019, Dr. Jacob Murray, Dr. Lyndsey Jones, myself, and our Advocacy Chair, Dr. Matlock Jeffries, traveled to Washington, D.C. to participate in the annual ACP Leadership Day on Capitol Hill. Leadership Day is a two-day program, this year held from May 14th through 15th, of panel discussions and lectures on a variety of health topics which culminate with visits to the offices of our congress members. During these visits, we discussed ACP's annual legislative agenda and asked for their support.

National ACP had eight key health priorities that they pushed for this year, including:

1. The High Cost of Prescription Drugs
2. The Epidemic of Firearms-Related Injury and Death
3. Funding Federal Workforce, Medical & Health Services Research, Public Health Initiatives
4. Physician Payment Under Medicare
5. Expanding Coverage and Stabilizing the Insurance Market
6. Reducing Unnecessary Administrative Tasks on Physicians and Patients
7. Health Women and Families
8. Medical Education Training and Debt

This year, our congress members were very busy, so much of our discussions took place with their legislative assistants and staff. We visited the offices of Sen. James Inhofe, Sen. James Lankford, Rep. Frank Lucas, Rep. Tom Cole, Rep. Kevin Hern, and Rep. Markwayne Mullin. Each discussion was limited to 15 minutes, so our "asks" had to be laser focused. We concentrated our discussions on 4 main priorities that we felt best reflected our state's priorities and those of our OK ACP chapter members.

Dr. Jones led the discussion on lowering prescription drug costs for our patients. Our "asks" on this topic included passing and introducing companion versions of The REMEDY Act (S. 1209) to aid in the approval of more generic drug applications by the FDA, Prescription Drug STAR Act (H.R. 2113) to promote drug pricing transparency by requiring "big pharmacy" to justify and explain price spikes on their drugs, The Medicare Prescription Drug Price Negotiation Act (H.R. 275/S. 62) to allow the federal government to negotiate lower drug prices on behalf of Medicare beneficiaries, and The CREATES Act (H.R. 965/S. 340) to prevent egregious practices by manufacturers that keep generic drugs from coming to the market. We all have experienced the frustration of high prescription drug costs that limit our patients' access to basic medications like insulin in our diabetics. These pieces of legislation would increase transparency and accountability in prescription drug pricing and improve access to lower-cost generic medications.

Dr. Murray led our discussion on reducing unnecessary administrative tasks on physicians and patients. Administrative burden on clinicians is a significant contributor to physician burnout. We all have experienced the frustration of medications being denied by insurance companies and all the hoops we have to jump through via prior-authorizations and step therapy protocols in order to get our patients the medications they need. Dr. Murray asked our congress members to introduce legislation that would standardize prior-auth reporting requirements across the entirety of the Medicare Program while also working with all stakeholders to adopt the same standardizations. Other "asks" on this topic included passing and introducing companion versions of The Safe Step Act (H.R. 2279) which would require health insurers to provide an exceptions process for any medication step therapy protocol based on clinical

decision-making, medical necessity, and other patient needs.

Dr. Jeffries advocated for continued, uninterrupted funding to several existing public health initiatives and federal health programs that currently support primary care and ensure an adequate physician workforce. Some of these I am sure you will be familiar with, including the CDC (Centers for Disease Control), NIH (National Institutes of Health), and VHA (Veterans Health Administration). Others you may not be as familiar with but are very important including the PCTE and NHSC. Particularly important to Dr. Jeffries, given his research in rheumatology at the Oklahoma Medical Research Foundation (OMRF), was continued funding of AHRQ (Agency for Healthcare Research and Quality) and PCORI (Patient-Centered Outcomes Research Institute).

I spoke with our congress members on Graduate Medical Education (GME) funding and medical student debt. GME funding has been an ongoing priority of ACP ever since I last attended Leadership Day in 2016. Because of the aging “Baby Boomer” generation, a 2019 report from the AAMC estimates a shortage of 21,000-55,000 primary care physicians by 2032. Every year, thousands of medical students go un-matched after receiving their medical degrees, preventing them from obtaining a state medical license and receiving further specialized training in residency. Both of these are essential in order to practice independently. Yet, the number of Medicare-funded GME positions has remained capped at the same levels since 1996. I asked our legislators to pass The Resident Physician Shortage Reduction Act (S. 348, H.R. 1763) which would increase the number of residency spots by 3,000 per year over 5 years with focuses in primary care like internal medicine. I also asked our legislators to pass and introduce companion versions of the Resident Education Deferred Interest Act (H.R. 1554) which would save physicians in residency programs thousands of dollars by enabling students to qualify for interest-free deferment on their loans while serving in a medical internship or residency.

As internal medicine residents, Dr. Murray, Dr. Jones, and I were all honored to represent our OU-Tulsa and OU-OKC programs at Leadership Day 2019! We are always advocating for our patients within clinic and hospital settings, but the experience and knowledge we gained advocating for them on Capitol Hill was invaluable. Later that week, I had another meeting in D.C. for ACP’s Medical Practice and Quality Committee (MPQC) where we discussed (and debated) ACP’s vision of our country’s future healthcare system. We anticipate this will be released to the public this November.
