#### APPOINTMNETS WITH LEGISLATORS



We are grateful to our Oregon Legislators and Staff who are working tirelessly on the behalf of Oregonians!! At this time – in the current Legislative Session – which would normally have taken place in-person at the Oregon State Capitol, they too are working remotely. We thank them for their hard work and for meeting with our advocacy constituents for furthering conversations about health care advocacy!!

We encourage you to reflect on your experiences with patients that connect to the legislative issues, since personal stories are a powerful tool in communications with legislators.

For those of you who registered for Appointments With Legislators---you will receive your appointment list – both by email and posted on the Advocacy Day HUB. Each Legislator Visit Team has a Team Lead. This person will be in contact with you about the appointments. At the end of the morning sessions----each Team will be in a Breakout Room and be able to organize and strategize for the visits with Legislators in the afternoon. Depending on your team's meeting schedule, you may have one or two meetings. If you have two meetings, you may have some down time between meetings. This time may be used to reflect on your last meeting, organize your team, continue practicing your roles, or research for the next meeting.

Once your team has concluded its final meeting, your day of advocacy training and service is complete. We encourage you to reflect/debrief as a group after your meetings before leaving for the day and to assign any follow up items to group members before departing. For example, if a legislator's office asks for an article or policy statement that comes up during the meeting, a team member should be assigned to follow up on this. 

Team Organization:

Teams have been organized to maximize opportunities to pair participants with their legislators, although not all participants will be able to meet with their own legislators. If you are meeting with your own legislator, please communicate this to the legislator or their staff during your meeting as this does carry weight with legislators. Teams are also organized with an eye toward balancing advocacy experience so that each team has a mix of first-time advocates and trainees paired with more experienced colleagues. But regardless of your level of experience, you will be prepared for your afternoon meetings during the morning sessions! Each Team should organize itself in decisions about who among the team will speak on specific issues or with specific legislators. For example, if a member of your team is represented by the legislator you are meeting, it makes sense for that member of the team to speak on an issue. You'll be in Breakout Rooms by Teams.

Follow Up: Regarding follow up with legislators, each of your Team Leads has sent Leave Behinds/Priorities for Oregon ACP Chapter to legislators. We encourage the legislative offices to contact the Chapter with any questions. Each office should receive at least one thank you note from your team. Please assign members of your team to write and send this. If there are other follow up items, these should also be assigned. If you would like to communicate any information about your meetings to Oregon ACP, please e-mail Joel Burnett (joelburnett.md@gmail.com. Similarly, please let Joel know if we need to provide additional information on an ACP position to one of the legislators you've visited. Regarding follow up with Oregon ACP, we are eager to learn about your experience and interest in continuing to advocate with us. Please be sure to complete the Evaluation Form. Please also follow up with us if you wish to get more involved in our advocacy work!
