Exhibitor Information

Size and Exhibits Types

- Exhibit space is limited to 6-ft table-top displays. Exhibitors must conform to this space requirement and should plan displays accordingly.
- Taping or hanging of materials on walls is prohibited.
- Due to limited space, exhibitors are limited to two exhibitor representatives at any given time.
- Electrical and internet connections are not provided by TXACP but may be ordered through the hotel.
- Exhibit table numbers and space assignments will be available to the exhibitors upon arrival for exhibitor set-up.
- Exhibitors are responsible for shipping, storage, and installation of exhibit materials and all costs involved.

Note: Shipping Information will be provided to exhibiting companies. Shipping information and forms to request electrical and internet services will be provided.

Exhibitor and Sponsor Policies

- ACP reserves the right to release your booth space if check payment is not received within 15 days of registering. Credit Card payments are taken at time of registration.
- All registrations made within 30 days of the meeting must be paid in full at the time of registration using a credit card.
- ACP reserves the right to assign exhibit space, change the floor plan, or move an exhibitor's exhibit space without prior notice if ACP determines that it is in the best interest of the annual meeting.
- Non-attendance does not constitute notice of cancellation. If an exhibit table is not set by the start of the meeting, the table may be assigned to a company on the wait list or converted to a common area.
- ACP reserves the right to restrict exhibits, without refund, that may be falsely entered.
- Distribution of literature, samples, etc., in the exhibit area by firms that are not participating as paid exhibitors is strictly prohibited.
- ACP and the meeting venue do not guarantee against theft, vandalism, or otherwise.
- Electrical and other apparatus must be operated so that the noise does not interfere with other exhibitors.
- All electrically wired display material must comply with the requirements of the National Board of Fire Underwriters.
- Aisles must be kept clear. Exhibits must be arranged so that exhibitors and their representatives will be within their exhibit space.
- It is understood that exhibitors shall indemnify and hold harmless
 ACP and the meeting venue all liability (damage or accident) that
 might ensue from any cause in connection with the transfer,
 installation, maintenance, or removal of exhibits, or in display of
 exhibits. It is understood that ACP will not pay for special
 equipment, facilities, and services ordered by technical exhibitors.
- Care must be taken by the exhibitor not to deface or destroy any
 part of the exhibit areas. In the event of property damage caused by
 him/her, the exhibiting company will be held responsible.
- Use of the name "ACP" or that of any officer of the ACP, in recommendation of a product or service, is prohibited.
