Al in Health Care: What Physicians Need to Know

Physician Non-Competes: What's Changed This Year?

Learn about the brand new changes to the Texas Physician's Non-Compete Statute (effective September 1). Karin will discuss the pro-physician reasons behind these important changes and how they may affect your non-compete. This discussion will also cover other restrictive covenants as these can also substantially limit a physician's ability to practice medicine when they join, depart, or otherwise make transitions to or from a practice or hospital.
