Leadership Day 2025

Twelve ACP Wisconsin delegates joined 500 ACP members from all 50 states to meet with members of Congress to lobby for vital issues for our patients and profession. We represented and met with Congress members or their staff from all eight Wisconsin congressional districts as well as with the offices of both U.S. Senators. The issues we addressed this year included:

- 1. Co-sponsor and support H.R. 879, the **Medicare Patient Access and Practice Stabilization Act**, a bipartisan bill that would stop the 2.83 percent cut in
 Medicare payments this yearwhile providing a 2 percent increase in payment for the remainder of 2025.
- 2. **Protect Medicaid Coverage**, by supporting policies that protect Medicaid coverage and ensure access to health care for our most vulnerable patients across the country.
- 3. Protect and Invest in Public Health Initiatives, Research, and Health Workforce, by rejecting arbitrary cuts, reorganization, and consolidation that degrades HHS and its ability to support research and deliver evidence-based public health services. Protect resources already appropriated and awarded and sustain funding for these public health programs in FY 2026, including: \$500 million for AHRQ, \$11.6 billion for the CDC, \$10.5 billion for HRSA, and \$51.3 billion for NIH.

Dr. Sophie Kramer, FACP and **Dr. Mara Terras, FACP** attended the April 15th Assembly Committee on Ways and Means Meeting, where Dr. Kramer testified in support of SB12. The proposed bill exempts gun safes and other "firearm safety devices" from sales and use tax in Wisconsin.
