Advocated on Key Public Health and Policy Issues

Years of ACP advocacy with Congress led to provisions in the Inflation Reduction Act that will improve public health, including: allows Medicare to negotiate the price of prescription drugs, caps out-of-pocket Medicare drug costs, eliminates Medicare cost-sharing for vaccines, improves subsidies for ACA health insurance, and makes significant investments to combat climate change

A leading voice in pressing Congress for common-sense firearm regulations that help to keep patients safe from firearm-related injury and death, ACP strongly supported passage of the Bipartisan Safer Communities Act, the first new law in decades designed to reduce firearm violence

Support for Physician Practices

Successfully advocated for changes in the 2023 Medicare Physician Fee Schedule that streamlines documentation requirements across E/M codes

As part of ACP's Patients Before Paperwork Initiative, collaborated with Medicine Forward on a webinar series to address the burden of prior authorization and solutions to mitigate unnecessary requirements

Supported "Improving Seniors Timely Access to Care Act" which streamlines prior authorization process and protects patients from unnecessary delays (passed the House of Representatives in September 2022)

Helped secure a 151-day extension to temporary telehealth coverage authorized under the COVID-19 public health emergency and continuing advocacy for the Advancing Telehealth Beyond COVID-19 Act, which would further authorize many of the currently temporary Medicare telehealth authorities






Prioritized Physician Well-being

Advocated for the passage of the "Dr. Lorna Breen Health Care Provider Protection Act," which is aligned with ACP's commitment to address the behavioral health needs of medical professionals

Campaigned to remove inappropriate mental health questions from state license and credentialing applications

Supported ACP Member Engagement in Advocacy

More than 370 ACP members participated in-person at ACP's Leadership Day in Washington, DC-attendees came from 44 states, 314 congressional districts, and participated in 99 congressional meetings addressing key internal medicine issues
