



IM-ITE®

The ACP Internal Medicine In-Training Examination® is a web-based self-assessment exam for residents to assess their progress.

About the Exam

The IM-ITE® is developed by a committee of expert physicians and is used by residents, program directors, and physicians alike. It is modeled after the American Board of Internal Medicine's certification exam. The exam is administered annually during a strictly monitored window.

The exam is designed to:

- Give residents an opportunity for self-assessment.
- Give program directors the opportunity to evaluate their programs.
- Identify areas in which residents need extra assistance.

About the 2023 administration

Programs will have the option for in-person testing or remote proctoring and testing or a combination of both, using third-party software (Zoom, MS Teams, or Webex).

Important dates for the 2023 IM-ITE

Regular registration will open May 3, 2023.

The 2023 Internal Medicine In-Training Examination (IM-ITE®) will be offered from August 17, 2023, through September 7, 2023, excluding Saturday, August 19 starting at 8:00 pm EST to Sunday, August 20 at 8:00 am EST (at total of 12 hours for system maintenance), and Monday, September 4, 2023 (Labor Day).

Registration Fee:

Regular registration - May 3, 2023, through July 17, 2023: \$135 per registrant

Late registration - After July 17, 2023: additional \$30 per registrant

The MyNBME® Services Portal provides programs the ability to update and manage the exam without contacting ACP or the NBME:

- Self-service administrative and registration tool
- Ability to list multiple contacts per program
- Ability to update and add registrants until exam day
- Quick retrieval of current and prior year score reports
- Easy access to all pre-registration and administrative documents
- Ability to update registrant demographic data when verifying roster after exam window

Before the Exam

- Residents are advised not to study for this exam.
- Special accommodations for those who need them can be made ahead of time. Residents should alert their program director of any special needs as soon as possible. *See information about Special Accommodations below.*
- A few weeks prior to the testing window, residents will be able to take the online practice exam to familiarize themselves with the online testing process.

Exam Day

- The total testing time will be 9 hours.
- There will be 7 hours devoted to the exam itself, plus several 10-minute breaks and a lunch hour.
- The exam will consist of 300 questions.
- There is no penalty for guessing an answer. Only questions answered correctly are counted toward the score.
- The exam will cover several subspecialties as well as general internal medicine.

After the Exam

- Results will be made available online to programs for distribution roughly 5 weeks after the exam window.
- Programs will receive a report that shows the percent of questions correct for each examinee as well as each examinee's percentile rank.
- Residents will also receive a report listing the educational objectives of questions they answered incorrectly.

Examinees Requiring Special Accommodations:

- All special accommodations requests and materials are due to ACP for approval no later than July 28, 2023.
- Examinees approved in 2022 will only need to return the authorization form.
