#### "Silent" Atrial Fibrillation: An Undiagnosed and Under-recognized Stroke Risk Factor

#### **Program Overview**

The proposed CME-certified and MOC-eligible educational initiative is designed to encourage physicians to be more aggressive in diagnosing paroxysmal and asymptomatic atrial fibrillation (AFib), and managing those AFib patients who are at high risk for ischemic stroke. Primary care physicians and associated healthcare professionals are being tasked with better diagnosing asymptomatic AFib and initiating appropriate anticoagulant therapy in those patients at risk for stroke.

#### **Learning Objectives**

- Identify patients who have high stroke-associated risk and undertake appropriate long-term monitoring.
- Use the CHA2DS2-VASc risk assessment score as a tool to determine the appropriate course of action to manage diagnosed atrial fibrillation.
- Consider appropriate oral anticoagulation for patients with newly diagnosed atrial fibrillation and a high CHA2DS2-VASc risk score
