Seeking Proposals to Name the Newest ACP National Award

Respond by: Thursday, February 15th

In November 2017, the Board of Regents established the **ACP Award for Outstanding Contributions to Advancing the Careers of Women in Medicine**. This award is bestowed on an ACP member for distinguished contributions to advancing the careers of women in medicine. This award also recognizes an individual who has furthered the careers of women medical students, residents, and/or physicians through mentoring and leadership development for the career advancement of women.

Before the inaugural recipient is selected by the 2018-19 Awards Committee in September, we invite Chapters to help identify an appropriate namesake by nominating a woman physician after whom the award should be named.

- Chapters can submit the name of one (1) distinguished woman physician after whom the award might be named.
- The Awards Committee will consider both living and deceased distinguished women physicians.
- The distinguished woman physician should be an ACP member (or should have been an ACP member during her lifetime).
- The distinguished woman physician need not belong to the Chapter submitting her name.

Please submit the following information to our Executive Director, Jan Wrassman at jwrassman.acpohio@gmail.com.

- One (1) letter detailing why you chose to submit this distinguished woman physician.
- Full curriculum vitae of the distinguished woman physician.
- Biography (one page maximum) of the distinguished woman physician.

In the event that a Chapter is submitting a deceased distinguished woman physician's name and does not have access to her curriculum vitae, the biography will be sufficient.

Our Nominations Committee will then review all submissions to determine which distinguished woman physician nominee will be submitted to national ACP.
